Three steps to slash medication costs

An employer's guide to reduce health care spending

Here, we've outlined three steps that can significantly help you lower costs:

Step 1: Pay for value

Build a clinical foundation based on value

When building a strong clinical foundation, group medications in tiers according to cost.

Value-based formularies are focused on delivering the greatest value for prescription spend. Medications are preferred based on their ability to deliver clinical benefit at the lowest net cost, whether they are rebated or not, and whether they are generic, brand or specialty.

Medications that add cost without any clinical benefit are excluded. As consumers take on more of the burden for drug costs via cost-sharing, a value-based approach makes it easier for them to afford the medications they need to get well and stay well.



Design a value-based formulary that improves:



Clinical quality

Your formulary should exclude high-cost drugs that demonstrate little or no improvement over comparable lower-cost medications.

That way you won't pay for medications that don't work.



Cost-effectiveness

Your formulary should limit the number of clinically proven therapies for specified medical conditions. Each group (or tier) should include only medications that offer the best clinical value and cost-effective price.



Consumer affordability

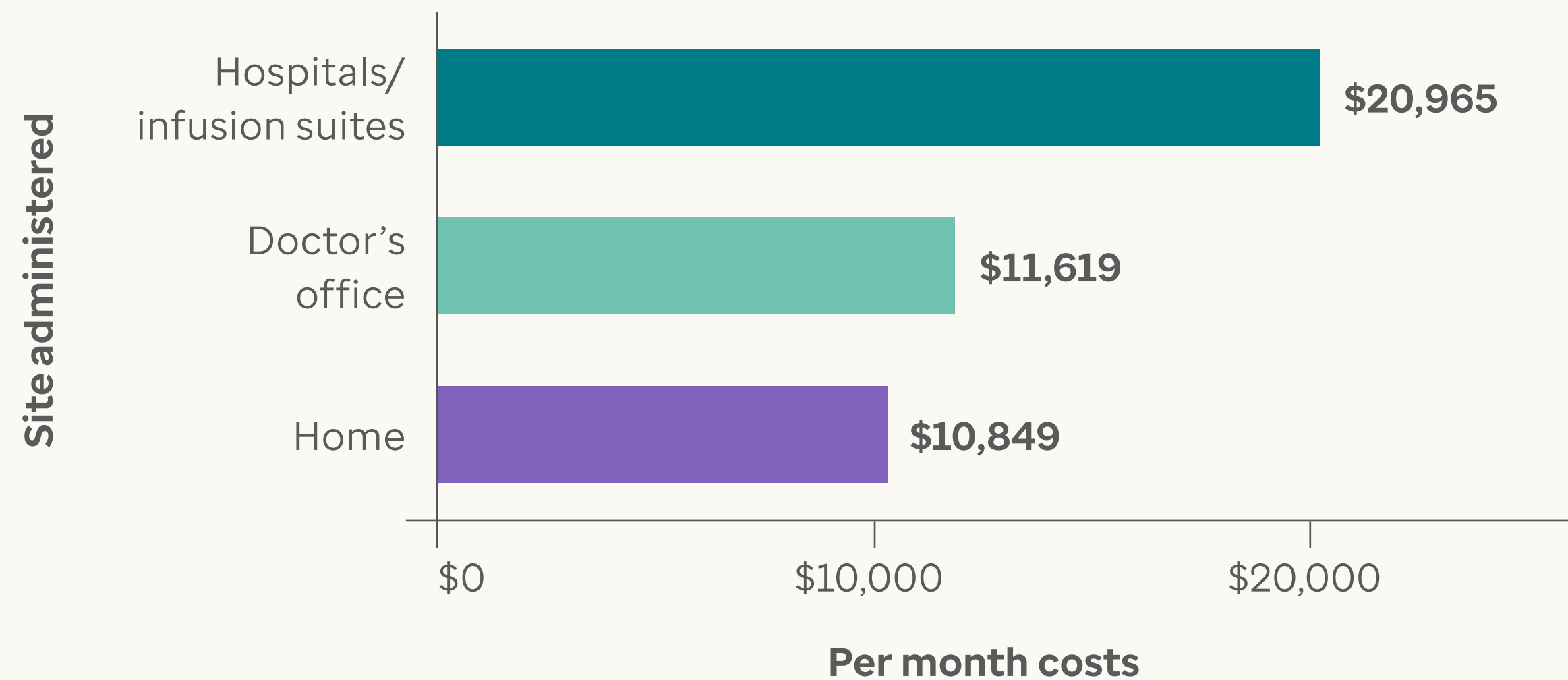
If there is more than one clinically effective drug in a class, a value-based formulary design can help patients save money by offering quality medications that work at the lowest cost.

Step 2: Take a good look at specialty costs

Keep an eye on infusion therapy costs

Specialty medications are rapidly approaching half of all medication spending. While specialty medications can be administered in a variety of ways, infusion therapies are a key driver of recent increases in specialty drug costs. Not only can infusion therapies be expensive, their cost can vary widely according to where they are administered.

Use a comprehensive approach to manage costs across benefits

Another unique aspect of specialty medications is that their costs occur across both the medical and pharmacy benefits. Use a specialty pharmacy to prescribe, fill and deliver medications to the provider in the hospital for administration.



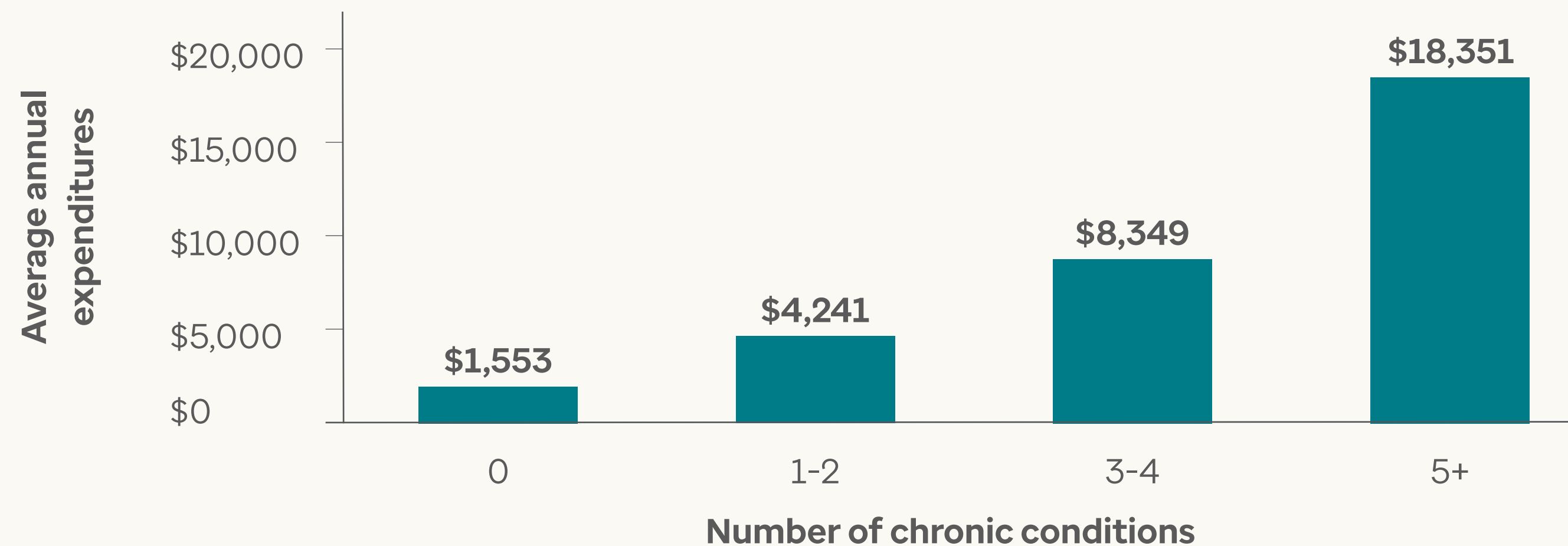
Step 3: Simplify complex care

Identification

Patients with complex conditions may see several different specialists, each of whom may prescribe medications. As a result, these patients end up taking multiple medications. Using advanced analytic technologies, pharmacy benefit managers can identify opportunities to intervene for better care.



Intervention

Clinical pharmacists review all the medications a patient is taking and work with them and their physicians to optimize treatment. This audit process includes anything from dosage adjustments to medication cessation. In addition to saving money on unnecessary prescriptions, this hands on counseling can help people avoid adverse drug events.



Pharmacy care delivery

Synchronizing prescription deliveries and refills dates and pre-sorting all the medications a person is prescribed into a single daily pack simplifies daily life and supports adherence.
